

Subject: Orders Appointing Special Process Servers

All motions to appoint special process servers should not name a company as the process server and should not contain more than two persons and must contain a certification that the individuals have been certified by the Florida Association of Professional Process Servers, some similar association, or provide proof that the individuals are certified in another circuit (i.e. a copy of their process server ID attached to the motion). If not, please use someone on the list provided.

Motions and proposed orders should be separate documents and the orders should contain a complete title.

Orders will not be entered appointing special process servers outside the jurisdiction of the Court.

Email addresses must be on the bottom of the order if copies are requested.

Please submit an Amended Motion that complies with the divisional procedures listed on the Judge's divisional procedure page on our website. Once the Amended Motion is filed you may submit a proposed order via E-mail in Word format.

Process for out of state:

Outside of the state of Florida the Judges don't have jurisdiction over process servers. Normally the Sheriff will serve out of state. If counsel has some legal authority, they can submit an amended motion. Judge Keim can sign an order denying without prejudice and allow counsel to file an amended motion with legal authority for the judge to sign their order. Or set a 5 min hearing if he chooses to discuss that issue with counsel.
